



ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an asymptomatic individual can be infected with and transmit COVID-19 without their knowledge.

Participation in a Crossways program, event or activity, or presence at a Crossways facility could increase the risk of contracting COVID-19.

NOW, THEREFORE, in consideration of being permitted to participate in programs, events, and/or activities offered by Crossways, or to be present at a Crossways facility, I understand, acknowledge and agree to the following: I have independently evaluated and reviewed the risks of being exposed to or infected with COVID-19 and have determined to participate in Crossways programs, events, and/or activities or to be present at a Crossways facility with full knowledge and acceptance of the risk. Fully understanding these risks, I, for myself, my child(ren), my spouse, my legal representatives, heirs, and assigns, hereby agree to assume full responsibility and liability for the risk of bodily injury, illness, permanent disability, and/or death which may result from exposure to or infection with COVID-19 before, during, or after participating in a Crossways program, event, or activity, or from being present at a Crossways facility.

I, for myself, my child(ren), my spouse, my legal representatives, heirs and assigns, hereby waive, release, and discharge Crossways, its officials, employees, volunteers, and agents from any and all liability to me, my child(ren), my spouse, my legal representatives, heirs, and assigns, for any and all losses or damages resulting from bodily injury, illness, permanent disability, and/or death caused by negligence of Crossways or its officials, employees, volunteers, and agents, which claims, losses, and demands arise during or result directly or indirectly from exposure to or infection with COVID-19 before, during, or after participating in a Crossways program, event, or activity, or being present at a Crossways facility.
